Challenge

The decentralized planning approach at the corporate level hardly allowed for analysis and detailed insights. Due to varying business models, it was challenging to compare contents, and yet the process was very labor-intensive for this purpose. To eliminate the increasingly unmanageable corporate planning, planning methods were standardized across business units globally and implemented in a modern CPM tool. Additionally, corporate planning and financial planning were dynamically integrated.

Approach

- Definition of a unified global planning model for core financial planning and business models (Mining, Production, EPC/Projects, Logistics, Sales).
- Alignment of the foundational model with all decentralized units worldwide.
- · Detailed conceptualization in a functional design document.
- Integration of specific local requirements from a U.S. subsidiary.
- Implementation of all planning modules in two phases (Core/Segments) with concurrent testing centrally and in overseas units, user training, and hypercare.
